## Website Privacy Policy

At the Oregon Mediation Association, we consider the privacy of our website visitors to be extremely important. This privacy policy document describes in detail the types of personal information is collected and recorded by [www.OregonMediationAssn.org](http://www.OregonMediationAssn.org) and how we use it.

- **Log Files:** Like many other Web sites, [www.OregonMediationAssn.org](http://www.OregonMediationAssn.org) makes use of log files. These files merely log visitors to the site - usually a standard procedure for hosting companies and a part of hosting services's analytics. The information inside the log files includes internet protocol (IP) addresses, browser type, Internet Service Provider (ISP), date/time stamp, referring/exit pages, and possibly the number of clicks. This information is used to analyze trends, administer the site, track user's movement around the site, and gather demographic information. IP addresses, and other such information are not linked to any information that is personally identifiable.
- **Cookies and Web Beacons:** [www.OregonMediationAssn.org](http://www.OregonMediationAssn.org) does not use cookies or web beacons.
- **Advertising Partners:** [www.OregonMediationAssn.org](http://www.OregonMediationAssn.org) does not have advertising partners.
- **Data Storage and Financial Transactions on Third-Party Sites:** The Oregon Mediation Association is committed to protecting member's data. OMA uses NeonCRM, a third-party web product, to store and maintain membership records. OMA data is not comingled with that of any other entity, and privacy is provided by NeonCRM's security systems. All financial transactions related to membership are conducted directly on NeonCRM; no member identifying or financial information is stored on the OMA web server.
