

Clarification Please? Mediation Marketing that Resonates

The five deadliest words in mediation: "It's a matter of principle." That phrase is usually the kiss of death for all hope of getting a mediated agreement. But does it really have to be that way? In this participatory workshop, share your ideas on how to resolve a disagreement deadlocked by this very subjective rationale. Participants will take away a toolkit to assist practitioners in making progress despite overwhelming odds. The presenter has no pat answers! He's been struggling with this for decades, and now turns to the "hive mind" for a lively discussion full of great ideas. All participants will be emailed a write-up of the group's conclusions.

Public Policy Mediation in an Age of Performance Politics

One of the emerging challenges of public policy mediation in an age of what some call "performance politics" is the trend toward stakeholder representatives being less and less interested in actual solutions, and more interested in demonstrating which "political tribe" they belong to. This workshop/seminar will examine these challenges and involve participants in developing strategies for overcoming them.

Hardcore Depolarization: Using Mediation Skills to Build Rapport Across Lines

Ryan Nakade · Mediator, Facilitator, Depolarization Ambassador

What does a mediator do when conflicting political or social positions do not want a seat at the mediation table? In this workshop, participants will learn practical strategies, tactics and methods that have been used successfully to address issues of hyper-polarization. The presenter will offer novel ways for how mediation skills can be used outside of traditional fields and, as a person of color who interacts with rural communities, will connect this work with social justice and equity-based values.

Participants will walk away with:

- An ambassador's method for building bridges using mediation skills to work with isolated communities or individuals who would not voluntarily talk to someone they viewed were from the other side.
- An increase in ideological competency around group values, ideals and beliefs.
- How to recognize intra-group polarization and skillfully move past wedge issues.
- Exploring internal paradoxes in order to facilitate breaking-up extreme groupthink.
- · How to introduce your perspective and when to use humble versus expert personas.
- Recognizing implicit ideological biases and building relationships through 1:1 dialogue.
- · The society-wide impacts of inter-group interaction and diverse community connection.
